- All vehicles are subject to inspection prior to entering car show
- Gate Opens at 7am, Registration Fee \$45 per vehicle.
- PARTICIPANT SHOW CARS - LINEUP AT ANGELS GATE 36TH/ GAFFEY ST. (See participant line up map)
- No Sirens or Loud Music, No Commercial Vehicles, No Starting of Engines during Show
- No In and Out once vehicles have been parked
- All participants must adhere to parking attendant's directions for parking your vehicles
- All vehicles will be lined up 6' or more apart from each other within the show grounds
- Fire lanes must be observed and not encroached upon as per LA City Fire Code 57.20.16
- Trailers may park at 22nd and Minor St. (see direction map)
- Groups wishing to participate together, must line up together
- No one is allowed to save show parking spaces
- Car show ends at 4pm, see map for traffic plan disbursement at 4pm
- Legends or Lions Club sponsors are not responsible for any vehicle damages upon entrance or exiting of event.
